Three common explanations why certain organisations have been so far ahead of the curve are:

- 1. They are so agile that they adapted to changes wrought by COVID much quicker than others.
- 2. They are so far sighted that they had prepared detailed plans for the inevitable moment to come, but not knowing when exactly that'd be.
- 3. Coincidence.

One such organisation is The Commons Project:








The CommonPass term is not generating interest until September 2020:

If we remove Switzerland from the list, as they are the host country of The Commons Project, we get a list of Western countries that most aggressively rammed through lockdowns and border closures.

Not countries with the highest population counts. Not countries with the poorest healthcare systems. Not countries with the most vulnerable citizens. Not even only countries in the Northern hemisphere, where respiratory illness season is between October and March, but including Australia and Singapore, which both shut their borders completely.

Formerly free countries which The Commons Project - or rather the people behind it - seek to subjugate with the trojan horse that is CommonPass.

As Prof. Richard Werner has shown in "Princes of the Yen", Japan has seen their fair share of large-scale economic and social re-engineering, i.e. controlled demolitions. Having largely failed, they are trying it again, starting with the ultimate coercion tool, a global ID that can punish dissenters by flipping a single bit in an electronic system that evades parliamentary or any other democratic oversight:

Japan plans to introduce "vaccine passports" to make it easier for people who have been inoculated against COVID-19 to travel internationally, government sources said Wednesday.

The passports are expected to be in the form of a smartphone app, with travelers scanning QR codes at airports before boarding flights or when entering the country.

The government is moving forward with the plan in the hope of resuming business travel that has virtually stopped during the pandemic, joining the **European Union**, the **Association of Southeast Asian Nations and China**.

"Other countries are doing it, so Japan will have to consider it too," Taro Kono, the minister in charge of the country's vaccination efforts, said in a parliamentary session Wednesday.

Kono had **previously voiced concern** that requiring certification of vaccination could lead to discrimination against **people unable or unwilling to receive shots due to potential allergic reactions or side effects**.

To allay such worries, the passports will also list negative results from polymerase chain reaction and antigen tests, the sources said. It is not expected that the scheme will be used domestically, for example to regulate entry into restaurants or sports events.

To recap:

The Commons Project, whose single product is CommonPass, became active in September 2019 when they could not have known about the upcoming pandemic.

In September 2019 Chancellor Angela Merkel happened to visit Wuhan, and also happened to visit the Wuhan branch of Webasto. A Chinese employee of Webasto happened to travel to Germany 5 months later, via a detour through Hong Kong, only to become patient zero in Germany. In September 2019 the Bill & Melinda Gates Foundation happened to pour \$55 million into BioNTech, a small company in Germany with not a single viable product at the time, and which happened to reside at the address An der Goldgrube in Mainz, which literally translates to At the Goldmine. In September 2019 the EU Commission held the Global Vaccination Summit in Brussels, which happened to feature representatives from the Bill & Melinda Gates Foundation and Facebook.

The Commons Project could not have started to plan this trojan horse years in advance, could they?
